• Economic strength:

Europe is Latin America's second largest trading partner and accounts for 36% of foreign direct investment in strategic sectors such as the automotive industry and digital technologies.

Models such as German dual apprenticeships have trained thousands of students in Mexico and Colombia, fostering innovation in areas such as robotics and sustainability.

Concrete results:

Initiatives such as Erasmus+ and AL-INVEST have had a positive impact on employability and the strengthening of small businesses and education systems.
